Ben Dov fortæller, at hun med Køpckes brev i hånden gik til tolden og fik sine billede ud. Hun forstår ikke, hvorfor der stod 17 billede på kvitteringen, men tror på at der kun var 16. Pengene til Nicolaus har ligget klar i tre uger, hun har skrevet til ham to gange, men han kommer ikke. Hun har haft mange udstillinger uden problemer på grund af god organisering og eksakt information. Det var Nicolaus' opgave at vejlede hende om priserne, han havde udtrykkeligt sagt at de var lave.
